2. The above promotion is subject to the following conditions:-
- (i) The promotion of the officers are made on "IN-SITU" basis i.e. such CAO, shall continue to work at the same place where they are presently posted till their posting orders for CAO are issued.
 - (ii) The promotion shall be subject to judgment dated 26.09.2018 of the Hon'ble Supreme Court of India in SLP (C) No. 30621/2011 (Jarnail Singh & Ors vs Lachhmi Narain Gupta & Ors).
 - (iii) Vigilance clearance in terms of DoP&T's O.M. No. 22034/4/2012-Estt.(D) dated 02.11.2012 and other relevant instructions on the subject. The chief Commissioner (Customs), CBIC where the Officer is working shall ensure that the Officer assumes charge of the post only after verifying that no disciplinary proceedings are pending or contemplated against the Officer.
 - (iv) If any of the above officer has taken VRS or has resigned or has expired, this order would not be applicable and the concerned Chief Commissioners/Pr. Chief Commissioners shall report the facts relating thereto to the Board immediately.

- (v) Para 6.4.4 of the DoP&T O.M. 22011/5/86-Estt.(D) dated 10th April, 1989 provides that promotions will have only prospective effect even in case where the vacancies related to earlier year(s). Accordingly, the promotion shall be effective from the date of assumption of charge of the post of Chief Accounts Officer (Customs). The joining report of officers may be furnished to the Board.
- (vi) If any Officer fails to avail promotion by **10th August 2021**, action to cancel his/ her promotion and debarment for promotion, in terms of DoP&T O.M. No. A-22011/5/86-Estt.(D) dated 10.04.1989 shall be taken against him/her.
