## **CIRCULAR**

## Sub: Priority Berthing for export of wheat-reg.

In supersession of earlier Circular No.PT.TF/SH/Berthing Policy/Corresp/2019-II/08 dated 01/04/2022 and in pursuance of Ministry's Letter No.PD-12026/3/2022-PD-IV dated 01/04/2022 regarding priority berthing for wheat vessels, the following amendments have been made in the Clauses no. (I) (ii), (iii) and (iv) to the extant Berthing Policy circulated vide Trade Circular No.TF/SH/Berthing Policy/Corresp/2019-II/882 dated 05/04/2021:

| (ii)  | Coastal cargo vessel   | 1 Berth  |
|-------|--|----------|
|       | Maximum one Wheat-loading vessel will be accommodated based on seniority in the absence of Coastal or Government priority vessels, subject to a minimum parcel size of 45,000 MT and a minimum ship-day productivity of 10,000 MT for each such Wheat-loading ship.  |          |
| (iii) | Priority group:  | 5 Berths |
| T.    | Two berths higher productivity, one berth 24 hrs, one berth 13500 MT and one berth 7000/5500 MT. In the absence of 24 hrs group, one Wheat-loading vessel will be accommodated based on seniority as 5th vessel, subject to a minimum parcel size of 45,000 MT and a minimum ship-day productivity of 10,000 MT. |          |
| (iv)  | Vessel carrying Steel  | 1 Berth  |
|       | In the absence of any vessel in this category, one project cargo vessel will be accommodated based on seniority.   |          |

Further, the Productivity Norms for all type of vessels carrying wheat is set at 10000 MT per
