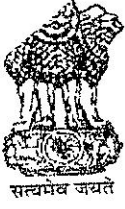

Sir,

The ministry of labour & employment is continuously working on improving life and dignity of labour force of country by protecting & safeguarding the interest of workers, promotion of welfare and providing social security to the labour force both in organised and unorganised sectors by enactment and implementation of various labour laws, which regulate the terms & condition of service and employment of workers.

Pradhan Mantri Shram Yogi Maandhan is a government scheme meant for old age protection and social security of Unorganized Workers (UW). It is a voluntary and contributory pension scheme under which the beneficiary would receive a minimum assured pension of Rs 3000/- per month after attaining the age of 60 years and if the beneficiary dies, the spouse of the beneficiary shall be entitled to receive 50% of the pension as family pension.

In this connection the Ministry of Labour & Employment, Govt of India conducting the AKAM Antyodaya Campaign between 28 April, 2022 to 26 July, 2022. Hence, it is requested to organise many number of camps on or before 26 July 2022 and register the unorganized workers like truck drivers, Cleaners, Crane Operators, Helpers, Casual workers and all other category of workers for Deen Dayal Port, Kandla in the PMSYM portal (<https://maandhan.in/shramyogi>) and the details of registration may be sent to this Inspectorate. The objectives of Pradhan Mantri Shram Yogi Maandhan pension scheme (PMSYM) and other relevant information are enclosed herewith for your ready reference.
