Subject - Using insights from FFFAI's member associations for augmenting trade facilitation measures in customs

The Board has received a request from Federation of Freight Forwarders' Associations in India (FFFAI), which is the national apex body of customs brokers' associations in India (list enclosed), for interactive meeting to provide all India insights for taking forward ease of doing business measures in connection with trade facilitation.

2. The undersigned is directed to convey that -

(a) The zonal Chief Commissioner of Customs may engage with the member CB association(s) relating to their jurisdiction. The engagement should cover different goods movement modes, such as sea, air, LCS/ICP - road/river/rail, ICD, CFS etc in the jurisdiction. The Chief Commissioner's team should include local systems manager. From holistic examination of insights received, practical suggestions be narrowed down along with describing the detailed mechanism of implementation and telling the advantages thereof. Each Chief Commissioner should convey these suggestions by 14.11.2022 simultaneously to the committee of Chief Commissioners of Customs (Nhava Sheva/ Delhi, Chennai/ Kolkata).

(b) This committee shall jointly examine the suggestions from all the zones and recommend a shortlist for the purpose of implementation. These recommendations shall be made after consultation with Pr. DG Systems, if any Systems related aspects are involved. The committee's report of recommendations is requested to be made by 30.11.2022 to the Board. It should be in two parts, first pertaining to recommendations which do not require the involvement of the Directorate of Systems, the second part with recommendations that do.
