***** C I R C U L A R *****

In supersession of Circular No. TF(A)/RP/Overstayal Cargo/06/1459 dated: 14/08/2020, it has been decided to permit Coal on rental / Penal rental terms as per duration mentioned below, based on parcel size of vessels and thereafter 2 (Two) times of ground rent charges shall be levied as per SOR.

1. Parcel size of upto 80000 mt- upto 3 months normal rent

For fourth month, If balance quantity is less than or equal to 60% of manifested quantity then normal rent will be charged.

For fourth month, If balance quantity is more than 60 % of manifested quantity then 2 times penal rent will be charged.

For fifth month, If balance quantity is less than or equal to 40% of manifested quantity then normal rent will be charged.

For fifth month, if balance quantity is more than 40 % of manifested quantity then 2 times penal rent will be charged.

From sixth month and above, the 2 times penal charges shall be charged on the balance quantity.

2. Parcel size from 80001 upto 120000mt- upto 4 months normal rent

For Fifth month, If balance quantity is less than or equal to 60% of manifested quantity then normal rent will be charged.

For Fifth month, If balance quantity is more than 60 % of manifested quantity then 2 times penal rent will be charged.

For Sixth month, If balance quantity is less than or equal to 40% of manifested quantity then normal rent will be charged.

For Sixth month, if balance quantity is more 40 % of manifested quantity then 2 times penal rent will be charged.

From Seventh month and above, the 2 times penal charges shall be charged on the balance quantity.

3. Parcel size of above 120001 mt- upto 5 months normal rent

For Sixth month, If balance quantity is less than or equal to 60% of manifested quantity then normal rent will be charged.

For sixth month, If balance quantity is more than 60 % of manifested quantity then 2 times penal rent will be charged.

For Seventh month, If balance quantity is less than or equal to 40% of manifested quantity then normal rent will be charged.

For Seventh month, if balance quantity is more than 40 % of manifested quantity then 2 times penal rent will be charged.

From Eighth month and above, the 2 times penal charges shall be charged on the balance quantity.

The above modifications will come into force from 14/08/2020.
