Sub.: - PF Compliance under EPF & MP Act - 1952.

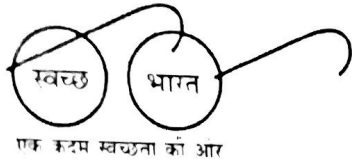
Sir,

With reference to the above subject, I would like to draw your attention towards the issue of the PF Compliance. Traffic Department has issued a Circular No. TF/SH/Labour Laws/2019/986 dtd.13-08-2020 regarding submission of PF Certificate/PF Compliance Report. Vide said Circular it was requested to comply as per the provision of scheme EPF & MP Act -1952 and to submit PF Compliance report either to the Asst. Provident Fund Commissioner or to the Traffic Department. Whereas it is observed that none of the Port Users have submitted PF report.

A letter No. TF/SH/Labour Laws/2019/ dtd. 06-08-2020 was communicated to the port users association directing all those port users/Trade License Holders to get registered under the scheme EPF & MP Act irrespective of having staff less than 20.

In view of above all the Port Users/Trade License Holder are hereby directed to extend the PF & Pension benefits to the employees engaged by them and submit the PF Compliance report within seven days.

It is brought to the notice of all registered Port Users in Traffic department, DPT, it is observed that the Port Users though having PF Code number but was found not complying since several years under the EPF Act - 1952, which is an contravention of the conditions/provisions laid under the Major Port Trust Act, 1963 (38 of 1963) and DPT Regulations 2019 which ensure compliance under EPF & MP Act 1952 vide G.S.R 187(E) 19TH Mar'2020.

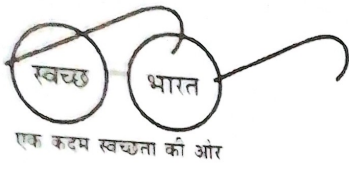

Sub.: - Registration of Port User with the EPFO for P.F Compliance under EPF & MP Act -1952 thereof.

Sir,

Traffic Department had issued circular No TF/SH/Labour Law/2019 dtd. 18-03-2020, where all the Port Users have to submit PF compliance report for getting the authorization for the financial year 2020-21. Some of the Port Users who got the authorization accepted by DPT has submitted that their firm is not covered under EPF & MP Act - 1952 as their firm is having less than 20 employees.

In this regard, as advised by the Asst. Provident Fund Commissioner, EPFO that all the Port Users/Trade License Holder who are registered with the Traffic Department Deendayal Port Trust and deployed or engaged their employee in the port related activity and entering into the port premises shall get registered in the Employee Provident Fund Organization under the scheme Employees Provident Fund & Miscellaneous Provisions Act - 1952.

Therefore, the concerned Port Users/Trade License Holders are hereby directed to get registered with the EPFO and comply all the rules & regulation under the scheme EPF & MP Act- 1952.
