

MINUTES OF THE MEETING OF PORT FACILITY ADVISORY COMMITTEE UNDER ISPS CODE UNDER THE CHAIRMANSHIP OF DY.CHAIRMAN DPT IN THE NEW BOARD ROOM AT 1600 HRS. ON 17.09.2021.

At the outset, Deputy Conservator and PFSO extended warm welcome to all the members who had come to attend the meeting. He stated that as per the ISPS Code, the Port Facility Advisory Committee meeting is to be conducted once every three months to review the security measures of the Port Facilities.

Initiating the discussions, Harbour Master deliberated in detail the points mentioned in minutes of the last meeting and requested the officials to state the status thereof on each point pertaining to their Department: -

1. Access Control System –

CME(I/c) informed that both of the High Mast Lighting Towers at Tuna are working and power back-up is also working at all Gates including Berth No.13 and 15 and also new cable has been replaced on 22.03.2021 for uninterrupted power supply.

It was stated that though the power backup has been restored but some time due to power failure/cable cut in some areas, the cameras are not visible.

As far as power back-up is concerned, Dy.Chairman directed CME(I/c) to resolve the same at the earliest.

Dy.CE stated that the CCTV cameras of Oil Jetty and Cargo Jetty analysis and survey were carried out and once RFID comes into force, the whole area will be covered under new CCTV cameras. Further, it was informed that boom barriers and tyre killers installed at gates and the same are now in working condition.

Sr.DD(EDP) stated that the RFID requirement was finalized after joint survey by CE, TM, CME, CISF, EDP, NISG and the requirements finalized by the team has been taken care in the tender. M/s. CEL has been awarded the work and first gate is likely to go live by 4th November, 2021 as per the presentation by CEL and consortium partner M/s. M Roads.

Dy.Chairman directed Dy.CE & Sr.DD (EDP) to take necessary action and sort out the above issues at the earliest.

(Action: CME(I/c), Dy.CE, Sr. DD(EDP))

2. Disposal of scrap / War Materials -

It is informed that the disposal of war materials has been initiated under the supervision of Custom Department & Army Officials and the same has completely disposed-off.

3. Conducting Drill and Exercises –

Commandant, CISF informed that Mock drill are being conducted on monthly basis with participation of Personnel of Fire Brigade-DPT, Marine Police & other stakeholders.

(Action: Comdt.CISF)

4. Lighting Arrangement in Cargo Jetty Area –

Port Users representative informed that the lighting arrangement in cargo jetty area has been improved but in the areas covering Jetty No.13 & 16, the illumination level is very poor.

Commandant, CISF stated that due to illumination problem during dark hours, there are chances of theft and robbery near the areas covering West Gates I & III. Sometimes, there is

power failure for 2 to 3 hours and many requests have been made to the sub station in that area to do the needful.

CME (I/c) stated that all cargo jetty lighting towers are working with sufficient number of fittings, lighting work is a routine maintenance work and is being attended the very next day of failure identification if any, to meet with the exigencies during power failure. A SOP is in process for formulation with planning to put all DG sets in auto mode during day time event and proposal of draft PO for procurement of 04 Nos. of DG sets is in process of Finance concurrence.

Dy.Chairman directed CME(I/c) that whenever the power goes out, DG set should turn on automatically. Till this problem is not resolved, staff should be kept stand by to start DG set round the clock.

(Action: CME(I/c))

5. Parking Area –

It was informed that as part of mandatory obligation under the security system, the vehicles should be parked on road sides creating blockage for the other traffic.

Dy.Chairman directed TM, CISF & Marine Police to carry out joint operation by both CISF and Marine Police and fine the vehicles which are being hazardously parked on the road.

IB representative stated that the truck drivers park the vehicle near the vessel whenever the loading process is going on the wharf. He stated that as per the ISPS regulation, the vehicle should be parked 50 meters away from the vessel.

Dy.Chairman directed Sr.DTM to issue circular to port users and take necessary action.

Commandant, CISF informed that Jetty No. 12 has an emergency gate but vehicles are parked in front of it which becomes difficult to open the door when there is an emergency.

Dy.Chairman instructed Sr.DTM to issue a circular mentioning that no vehicle should be parked near the emergency gates.

(Action: TM/Comdt.CISF)

6. Patrolling in the port area –

It was reported by the officials of Marine Police and CISF that regular patrolling works are going around the Port. Commandant,CISF stated that sea patrolling team carries out intensive patrolling round the clock in main channel of DPT from Cargo Jetty to Oil Jetty.

IB representative informed that the roads connecting Gandhidham-Khari Rohar-Kandla have pipelines on one side and needless vegetation have covered that place which causes difficulty while going through those areas and moreover there are causes of theft/robbery. Further, it was also informed that port users have also agreed for give their contribution to develop the lighting facility at Gandhidham-Khari Rohar-Kandla.

Dy.Chairman directed CME(I/c) to examine the matter and initiate immediate action.

(Action: Comdt.CISF/CME(I/c))

7. Scanner System at Gates –

Commandant,CISF informed that there is utmost need for scanner at North Gate and Oil Jetty areas. To which CME(I/c) informed that procurement of 03 Nos. of Scanners has been floated through GEM with due date of opening as 26.09.2021.

Dy.Chairman directed CME(I/c) to take necessary action.

(Action: CME(I/c)/Comdt.CISF)

8. Issuance of Smart Cards -

Sr.DTM informed that action has been initiated to issue Smart cards. The work has been awarded to M/s. Genesis Solution. The same will be done in a short time.

Dy.Chairman directed Sr.DTM that training certificate and medical certificate are required at the time of issuing the gate pass (Smart Card).

(Action: TM/ Comdt.CISF)

The meeting ended with vote of thanks to the Chair.
