MINUTES OF THE MEETING OF NATIONAL COMMITTEE ON TRADE FACILITATION

Reference: (i) Note from Central Board of Indirect Taxes and Customs (CBIC), D/o Revenue received on 22.08.2022 via e-mail.

(ii) PPT from CBIC received on 25.08.2022 via e-mail.

The 6th meeting of the National Committee on Trade Facilitation (NCTF) was held under the chairmanship of Cabinet Secretary on the above subject. The list of participants is at **Annexure-I**.

- 2. Revenue Secretary, in his introductory remarks, stated that under the aegis of NCTF, India has now become fully compliant with WTO Trade Facilitation Agreement (TFA). He highlighted the improvements w.r.t international benchmarks.
- 3. Chairman CBIC observed that considerable progress has been made towards Ease of Doing Business and transparency. There has been improvement in Release Time for Imports and Exports. Going forward, he stressed the need to focus on EXIM cost reduction, increase in the efficiency of regulatory approval processes of Partner Government Agencies (PGAs), and improvements in logistics and infrastructure, and achieve cargo release time targets.
- 4. JS, Customs made a presentation covering the progress since 5th NCTF meeting, fulfilling the commitments under FTA, key findings of National Time Release Study 2022, National Trade Facilitation Action Plan (NTFAP) 2020-23, benefits of trade facilitation measures and next generation trade facilitation reforms (**details at Annexure III)**. He pointed out that after Customs clearance, considerable time is spent on logistics resulting in longer Release Time. Secretary, Ministry of Ports, Shipping & Waterways stated that delay is observed in movement of cargo from Container Freight Station (CFS) to terminal. DPIIT is working on RFID real time tracking system, which will enable better monitoring.
- 5. Members of Trade were requested to give their feedback. While appreciating the Ease of Doing Business efforts of the government, they made specific suggestions for trade facilitation (details at Annexure II).
- 6. Commerce Secretary suggested conduct of a study for E commerce sector similar to Time Release Study. He suggested that a common portal may be created that would

act as single repository for country/FTA wise tariff as well as procedure related information. He also suggested that the Steering Committee under NCTF should meet more often to resolve pending infrastructure, technology and regulatory issues impacting cross border trade.

- 7. Cabinet Secretary complimented D/o Revenue for fulfilling the WTO commitments as well as implementing other initiatives aimed at trade facilitation. He observed that further improvements need to be made in respect of indicators such as Release Time for Imports and Exports and the goal should be to match the best in the world in trade facilitation.
- 8. After detailed deliberations, the Committee recommended the following:
 - (i) All stakeholders should mandatorily comply with the Standard Operating Procedure (SoP) issued in 2020 for issuing any new **Non-Tariff Measures** (NTMs). NTMs issued prior to issuance of SoP be immediately notified to CBIC for issuance of Centralized Control Number. Secretary Revenue may hold a meeting with the Departments concerned to expedite the notification of remaining NTMs to CBIC.
 - (ii) All the Partner Government Agencies (PGAs) should integrate their Risk Criteria with the Indian Customs **Risk Management System** (RMS) for improving the overall facilitation percentage. Animal Husbandry should finalise their risk parameters and share the same with Indian Customs RMS. These actions may be completed in a month's time.
 - (iii) DoR should strive to complete the full scale roll out of CBIC's **Single Window Phase-II** well before the present timeline of December, 2023. Secretaries of the PGAs concerned should appoint a nodal officer for each PGA to expedite the process of integration.
 - (iv) In respect of **Drawback claims**, CBIC should put in place a mechanism by November 2022 to ensure that the amounts get regularly credited into the exporters' accounts within 3 working days.
 - (v) Physical Infrastructure at Land Customs Station (LCS)/Integrated Check Post (ICP) should be strengthened to facilitate the cross border trade with the neighbouring countries. Ongoing infrastructure augmentation including at Chennai, ICP Petrapole and ICP Raxaul should be expedited. Home Secretary may hold a meeting on Land Ports Authority to strengthen the infrastructure at LCS/ICPs in a time bound manner.
 - (vi) A committee comprising Member CBIC, representatives from Ministry of Ports, Shipping & Waterways and other stakeholders should examine the reason for high release time after customs formalities.
 - (vii) The issue of time taken at payment stage by importers should be discussed in detail by Chairman CBIC with representatives of trade and appropriate measures taken to bring it down and suggest suitable measures for timebound implementation.
 - (viii) The Steering Committee, co-chaired by Revenue Secretary and Commerce Secretary should interact with the trade on regular basis to explain trade

facilitation initiatives undertaken and take forward NTFAP, and address the issues raised by trade.

- (ix) While bringing customs administration in **SEZs** on the Customs National Portal, DoR should ensure that the quality of service presently available in SEZs is not impacted negatively.
- (x) DoR should closely monitor Implementation of the remaining 36 action points under the **NTFAP 2022-23**, within the stipulated time line.
- (xi) Suggestions given by the Trade may be taken up for appropriate action. Revenue Secretary and Chairman CBIC may hold a follow up meeting with the representatives of trade bodies in this regard. Action Taken Report in this regard may be presented in the next meeting.

The meeting ended with a vote of thanks to all participants.



The representatives from Trade expressed their appreciation for the work done by all the ministries for trade facilitation and to further enhance the trade facilitation made following suggestions.

- (1) Authorised Economic Operator (AEO) scheme may be extended and aligned with similar schemes of other countries with whom India has entered into Free Trade Agreements.
- (2) Shipments of AEOs are being examined on frequent basis and CBIC is requested to look into the matter to accord enhanced facilitation levels to the AEO clients.
- (3) Publishing of confidential trade data in public domain by companies should be checked and penal provisions may be invoked as per law against the defaulters.
- (4) The frequency of scroll generation of Remission of Duties and Taxes on Exported Products (RoDTEP) and Rebate of State and Central Taxes and Levies (ROSCTL) should be increased.
- (5) There is inordinate delay in uploading shipping bills for exporters at Land Customs Stations.
- (6) Create a paperless and faceless trading ecosystem and strengthen the effectiveness of the online grievance redressal mechanism for trade facilitation related matters.
- (7) All the PGAs should set defined timelines for clearances of goods/issuance of NOC.
- (8) Uniformity should be brought in Customs procedures at different ports.
- (9) Re-examine and review the current provisions related to rejection of AEO applications / renewals based on 'current assets' and 'Show Cause Notice invoking limitation'.
- (10) Difficulties are faced by trade due to difference in use of Harmonised System of Nomenclature (HSN) code between the Customs and GST regime.
- (11) The process of issuance of Certificates of Origin should be fully digitised to overcome the signature mismatch issue in the manual process.
- (12) BIS standards are not accessible digitally to Customs for adherence by exporters.
- (13) The PGAs should accord enhanced facilitation to the AEO clients in order to reduce the average release time of cargo.
- (14) Efforts should be made to reduce cost of doing business and minor offences should be decriminalized.
- (15) Scope of the RoDTEP scheme should be reviewed to include more sectors and the rates of RoDTEP should be reviewed.
- (16) Data privacy and data sharing laws should be strictly implemented to maintain industry competitiveness.
- (17) Standardised examination order should be issued to field formations by CBIC.
- (18) Currently the cargo handling, shipping and logistics cost is very high in India which needs to be regulated by the Ministry of Port, Shipping and Waterways to reduce the overall cost of doing Business and make Indian exports globally competitive.
- (19) Bring more transparency regarding charges levied by shipping lines by creating a common dashboard.
- (20) The exercise of PGAs integration in Single Window should not lead to creation of parallel systems by both Customs and PGAs resulting in duplication of efforts/time at the end of traders.




