		Development of Container based training center at west gate- 1 is under progress. It is predicted that center will be commissioned within a month time.
6.	Medical Examination of workers & First Aid Center:	Tender proposal for the development of occupational health center and first aider is pending with CMO.
7.	Condition of pipelines serving water to fire hydrants.	Repairing/replacement of fire hydrant line to be completed and hydro test to be conducted as it is pending.
8.	Structure Stability Test	Repairing work of berth No.7 has been started.  Back filing work of the berth No.16 is under progress.  Demolition work of total 3 nos. of old warehouses is under progress.
